OVER 400 CHILDREN PARTICIPATED IN WEEKDAY, WEEKEND AND SCHOOL VACATION PROGRAMS, WHILE OVER 7,000 SCHOOL AGE STUDENTS WERE VISITED EITHER IN THEIR SCHOOLS OR OUT ON FIELD TRIPS TO THE VAN VLECK FARM & NATURE SANCTUARY. ON SITE, THEY LEARNED ABOUT IMPORTANT NEW ENGLAND TRADITIONS, SUCH AS RAISING FARM ANIMALS AND MAKING MAPLE SYRUP AS WELL AS DISCOVERING THE WONDERS OF THE NATURAL WORLD THROUGH INTERPRETIVE VISITS TO FLANDERS PONDS, WOODS, MEADOWS, FARM AND ART STUDIO. WE CAREFULLY MANAGE THE LAND TO RETAIN ITS ECOLOGICAL HABITATS AND ENSURE THAT THE OPEN SPACE IS PROTECTED FOR FUTURE GENERATIONS TO ENJOY. IN ITS ROLE AS STEWARD, FLANDERS MANAGES AND MONITORS THE PROPERTIES IT OWNS WHILE PRESERVING THEIR NATURAL BEAUTY AND CARING FOR THE ECO-SYSTEM AS A WHOLE.
