In 2020, Flanders Nature Center & Land Trust provided year-round children's science classes and educational workshops, including popular summer camps and academies. Over 500 children participated in summer and vacation programs. Thousands more participated in school day programs -either in-person field trips, Flanders at-your-school programs, or part of our new Live-Virtual programs. Flanders adult education and family offerings around the themes of art, farm, nature and conservation continued to grow.**4b** (Code:) (Expenses \$ 64,678. including grants of \$) (Revenue \$)Land Acquisition: Flanders added 54 acres of beautiful forested land to its protected properties in 2020. The two "Tomlinson parcels" of land are contiguous with other lands protected by Flanders, increase Flanders easement, and fee holdings to 2,423 acres. Since 1973, through its land trust activities, Flanders works to retain the rural character, ecological integrity and quality of life in the greater Waterbury area.**4c** (Code:) (Expenses \$ 43,911. including grants of \$) (Revenue \$)Land Stewardship: Flanders serves as the steward of 50 plus open space properties, totaling 2,423 acres in Woodbury, Middlebury, Bethlehem, and Southbury. We are dedicated stewards of the land and manage each property to retain its ecological habitat and ensure that the open space is protected for future generations to enjoy. In its role as steward, Flanders manages and monitors the properties each year while preserving their natural beauty and caring for the eco-system as a whole. These open spaces provide the community with wonderful places for quiet contemplation and low impact recreation including a number of terrific hiking preserves. Flanders maintains the health of its open spaces and nature preserves, so that the woodlands, wetlands and trails remain open for everyone to appreciate and respect, use and enjoy.**4d** Other program services (Describe on Schedule O.)

As a Land Trust Alliance accredited land trust, Flanders has written multiple policies regarding monitoring, inspection, handling of violations and enforcement of conservation easements. The organization maintains a schedule of monitoring easements regularly and ensuring that the conservation values for which the easement was created are in fact being conserved.

Flanders is a land protection organization which may accept conservation easements which are an encumbrance on a property that creates a legally enforceable land preservation agreement for the purposes of conservation. Flanders does not recognize these easements as assets on the statement of financial position.

Part III, Line 4 - Description Of Organization Collections & How Furthers Exempt Purpose

The organization maintains a collection of antique hand farm tools. These tools are part of the educational programs illustrating New England traditions such as raising farm animals, growing crops, making maple syrup and bee keeping.

The Nature Center owns 282 artworks created by Natalie Van Vleck. Much of the collection is on display at the Nature Center's headquarters. This artwork is being preserved in accordance with a grant received by the Nature Center in 2000.

Part V, Line 4 - Intended Uses Of Endowment Fund

The organization's endowment consists of two categories of funds: 1)Current Operating and Project Funds, and 2)Long-term Funds. The long-term funds are invested to appreciate and generate on-going income or reserves to benefit the mission, programs or specific projects at Flanders. The long-term funds are unitized to reflect general funds that are unrestricted, and other funds to endow its mission programs. The Board allocates a certain percentage of the income from the invested funds to be drawn for operating expenses each year. All long-term funds are defined as to whether they are unrestricted, permanently restricted by donor instructions, temporarily restricted, or Board designated temporarily restricted (held as reserves for projects or invested to generate income for specific mission areas).
